## **ITEMS SCHEDULED:**

- a. Board of Trustees membership:
  - i. Board Chairman Dr. Bill Reed has welcomed new members and introduced them to the Board activities and functioning
  - ii. Alexandra Oravcova has been reconfirmed as the Board Secretary
  - iii. Plan for establishing BoT committees (Finance, Government, Academic, Audit) the BoT members have been informed about the necessity to form BoT committees. Nominations for individual committees will be discussed and candidates chosen in the next BoT meeting.
- Current LIGS situation LIGS University President Dr. Pavel Makovsky has
  presented a detailed report regarding the enrollment levels in individual programs
  and financial situation of the university.
- Dr. Makovsky has shared information from Graduation ceremony, which has taken place in September 2021 (video from the ceremony: <a href="https://youtu.be/OpjPaz4EZ7k">https://youtu.be/OpjPaz4EZ7k</a>)
- d. Dr. Makovsky has welcomed and introduced the new Senior Vice President of LIGS University Dr. Alan Krautstengl. Dr. Krautstengl is going to focus on preparation of the GAP analysis of LIGS University preparedness for accreditation



by a regional and / or national accreditation body in the USA. The analysis is due by the end of 2021.

- e. Development plan for LIGS University in the upcoming academic year Dr. Makovsky has shared a plan to "restart" LIGS University in the following areas:
  - i. acceleration of accreditation efforts
  - ii. increase the number of MBA students
  - iii. return to the cutting-edge of innovation in online learning (materials, videos, webinars, specializations)
  - iv. development and implementation of new business models (online conferences for MBA and PhD students; individual short-term courses)
- f. Accreditation the Board has discussed the future of accreditation efforts of LIGS University. The topics in question were whether to pursue accreditation from DEAC or WSCUC, and which degree programs to accredit. The GAP analysis conducted by Dr. Krautstengl should help in making the decision. The discussion will continue at the next BoT meeting.
